ROLE SUMMARY / PURPOSE	
<p>Provide registrar services to geriatric patients of Albury Wodonga Health (AWH).</p> <p>A full range of registrar level geriatric medicine expertise is required. This includes management of inpatients under the Geriatric (GEM) Units at AWH, supervision of junior medical staff, providing consulting services to other clinical units, providing patient assessments for entry to geriatric services, providing services to specialist geriatric clinics. The position also provides the opportunity for student and junior medical staff teaching and education.</p> <p>The Geriatrics Registrar will work closely with other health professionals and hospital management in delivery of clinical services.</p>	

Local Work Environment:

AWH Geriatric Unit locates on Wodonga Campus. The unit offers both inpatient (10 – 15 x Acute and Geriatric Evaluation Management beds), inpatient geriatric consultations including orthogeriatric support and ambulatory geriatric services of Fall and Balance Program, Cognitive Dementia and Memory Service, as well as General Geriatric Clinics for a major region health covering extensive North East Victoria and Southern NSW regional and rural areas. Specialist areas of interest include delirium management, orthogeriatric support, cognitive assessment and comprehensive geriatric assessment.

The service also works closely with a well-established Rehabilitation Service.

ORGANISATIONAL RESPONSIBILITIES**Clinical:**

- Provide effective, efficient and professional clinical care and advice to patients and families referred to or managed by the geriatric service.
- Work within a multidisciplinary health care team to promote high quality outcomes for patients.
- Participate in case conference and other interdisciplinary processes for the optimal care of patients and their families / carers.
- Perform patient assessment, clinical examination and procedures as required and appropriate to the level of Registrar.
- Provide clinic services and consulting services at both Albury and Wodonga campus under indirect supervision.
- Supervise and provide guidance to junior medical staff and other health professionals.
- Maintain clinical notes and reports.

Management, Quality and Education:

- Assist in the development, implementation and monitoring of departmental quality and clinical risk management.
- Participate in regular departmental audit/peer review activities such as morbidity / mortality review.
- Attend to enquiries and complaints from patients, relatives, staff or management in an appropriate and timely manner, discussing potential problems with the Director of Medical Services, the Staff Geriatricians.
- Demonstrate evidence of continuing education and professional development. AWH can also support additional Vic geriatric training program which usually be host in Melbourne regularly.
- Provide regular training and education programs to junior medical staff.
